  - Group discussed what they have learned about their community by going through COVID-19 together
- Individual Perspective – 1268 completed surveys
  - Respondent Demographics
  - Rate Your Overall Health
  - Rate Bullitt County as a Healthy Area
  - What are the 3 greatest problems in Bullitt County?
  - What are the 3 biggest barriers that prevent residents of Bullitt County from being healthy?
  - What are the 3 most important things needed for a Healthy Bullitt County?
  - Where do you currently look for information on or about your health?
  - Networks of support for individuals during times of stress and need?
  - Is Bullitt County a Safe place to live?
  - Community groups and leaders are working together to achieve the same goals in Bullitt County?

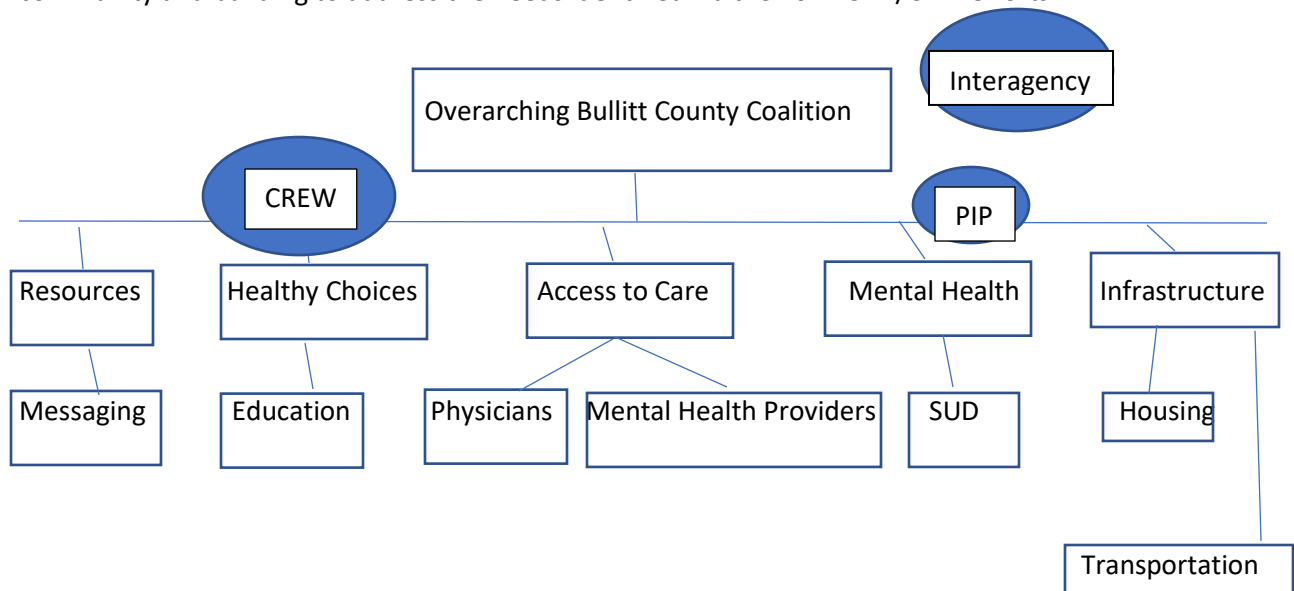
### Last Community Health Assessment/Community Health Improvement Plan
